

BYLAW NO. 1/2019

RURAL MUNICIPALITY OF BROCK NO. 64

A BYLAW CONCERNING THE ERECTION OF TRAFFIC SIGNS

AND BRIDGE WEIGHT RESTRICTIONS

The Council of the Rural Municipality of Brock No. 64, in the Province of Saskatchewan enacts as follows:

1. In this Bylaw, the expression "road" means any public road within the Municipality as defined by the Highway Act, other than that of the Provincial Highway as designated pursuant to such Act.
2. Signs containing the word "Stop" shall be erected at the roadways at the following locations

3. All signs erected pursuant to Section 2 shall be erected not less than three meters and nor more than fifteen meters from the edge of the intersection roadway.
4. The Provisions of the vehicle act shall apply, whenever applicable, to every sign erected Pursuant to section 2. pde
5. Any person who violates any provision of this bylaw shall be guilty of an offense and shall be liable to a summary conviction to the penalties in the General Penalties Bylaw of the Municipality.
